NOTIFICATION REGARDING OPPORTUNITY TO PARTICIPATE IN ENVIRONMENTAL AUTHORISATION APPLICATION PROCESS FOR THE PROPOSED TOSACO BLOCK 1 EXPLORATION RIGHT EIA PROJECT, LOCATED OFFSHORE EXTENDING FROM ALEXANDER BAY TO APPROXIMATELY HONDEKLIP BAY, NORTHERN CAPE, SOUTH AFRICA.

Tosaco Energy (Pty) Ltd (hereafter referred to as the applicant - Tosaco) has appointed Environmental Impact Management Services (Pty) Ltd (EIMS) as the Environmental Assessment Practitioner (EAP) to assist with undertaking the required authorisation processes (including the statutory public participation), and to compile and submit the required documentation in support of application for:

- Environmental Authorisation (EA) in accordance with the NEMA- Listed activity/ies:
