NOTIFICATION REGARDING OPPORTUNITY TO PARTICIPATE IN ENVIRONMENTAL AUTHORISATION APPLICATION PROCESS FOR THE PROPOSED ESKOM DELPHI SUBSTATION EXPANSION, NEAR KOMANI IN THE ENOCH MGJIMA LOCAL MUNICIPALITY, EASTERN CAPE.

Eskom Holdings SOC Limited (hereafter referred to as the Applicant) has appointed Environmental Impact Management Services (Pty) Ltd (EIMS) as the Environmental Assessment Practitioner (EAP) to assist with undertaking the required authorisation processes (including the statutory public participation), and to compile and submit the required documentation in support of application for:

- Environmental Authorisation (EA) in accordance with the NEMA- Listed activities:
 - Listing Notice 1 (GNR 983): Activities: 19 and 47
 - Listing Notice 3 (GNR 985): Activities 12 and 23
- Water Use Licence (WUL) in accordance with the National Water Act – NWA (Act 36 of 1998) - Listed activity/ies:
 - Section 21 (c) and (i);
 - Section 21 (g)

Additional listed activities and/or water uses may be identified during the process.

The Applicant wishes to expand the existing Eskom Delphi Substation to make provision to connect an additional 300 MW to the 100 MW which has already been approved up to bid Window 5 (BW5). As such, an expansion of the 400kV and 132kV bays are required. The project will involve the extension of the existing 400 kV yard by one bay, installation of a 400/132 kV 500 MVA transformer, extension of 132kV yard by seven bays, equipment of one 132kV transformer bay, relocation of the existing oil dam, and access road extension. This project forms part of an initiative to unlock grid capacity by connecting renewable energy generation by year 2027. The Eskom 2022 Transmission Development Plan (TDP) generation assumptions forecasts that 31 095 MW of PV and wind generation will be required nationally by 2030 of which 16 604 MW will be required as early as 2027. Currently there is limited or no capacity available in many of the Transmission supply areas.

The proposed project is located on Portion 3 of the farm Carthcarts Gift 311, within the Enoch Mgijima Local Municipality, Eastern Cape Province. The site is approximately 14km south west of Komani along the R67. The centre point of the site is 32° 0'41.18"S and 26°48'30.22"E. Please refer to attached project locality map.

EIMS will be following the procedures defined in the Environmental Impact Assessment (EIA) Regulations (GRN982 of 2014, as amended) for undertaking a Basic Assessment process. In accordance with Chapter 6 of the EIA Regulations, a public participation process will be undertaken. You are hereby invited to register and comment on the proposed project and application/s. In order to ensure that you are identified and registered as an I&AP and that your comments are captured, please submit your name, contact details, the reason for your interest or any , in writing or telephonically, to EIMS. Ngoko ke, kuyafuneka ukwandiswa kweebheyi ze-400kV kunye ne-132kV. Le projekthi iza kubandakanya ukwandiswa kweyadi ye-400 kV ngebheyi enye, ukufakelwa kwe-400/132 kV 500 MVA transformer, ukwandiswa kweyadi ye-132kV ngebheyi ezisixhenxe, ukufakwa kwe bheyi enye ye 132kV transformer, ukufuduswa kwedama le-oyile esele likho, kunye nokwandiswa kwendlela yokufikelela. 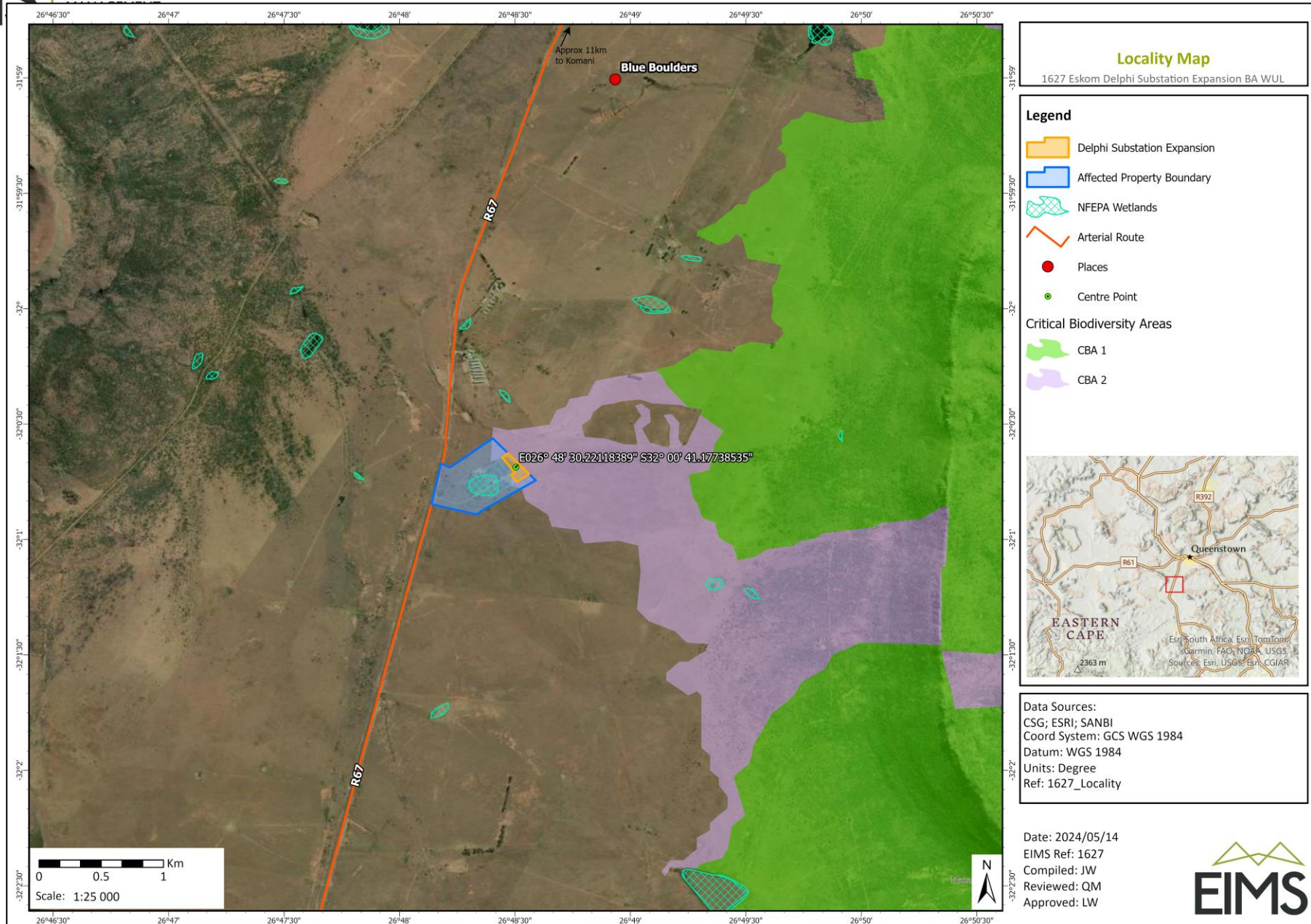

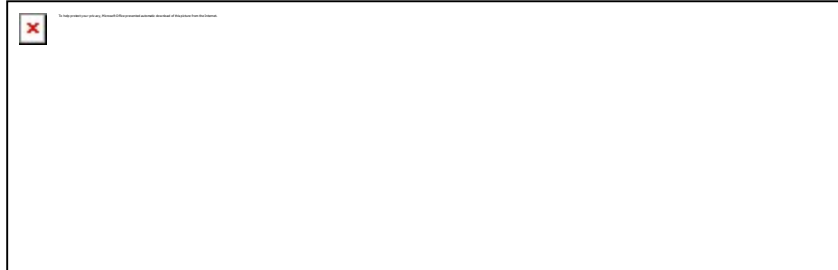
